Minutes from Prior Annual Meeting held January 26, 2025

WOHA President Peter Lund called the meeting to order and after quorum was verified, acknowledged the organization's 50th Anniversary and its on-going legacy. He thanked loyal members for their generosity and volunteers for their devotion.

Former WOHA President Ed Einstein, who has also served as President of the Club, discussed the Club's longstanding financial challenges and encouraged WOHA members to consider a potential proposal of a loan in the future.

Lund called for approval of the prior Annual Meeting's minutes. No questions were raised. Attendees marked paper ballots.

Lund called for approval of the Treasurer's Report. \$46,232 revenue raised in FY24 driven by 51% HH membership. Cash on hand of \$164,287 including Oak Wilt Reserve earmark. \$61,982 in FY24 expenditures was 6% below budget with common area upkeep the largest expense. Proposed FY25 budget: \$60,789 anticipated revenue from all sources, anticipated \$68,878 in expenses driven by upcoming golden anniversary event and finalization of Covenant Amendment campaign. An attendee suggested that periodic audits be conducted. Attendees marked paper ballots.

Lund called for approval of proposed By-Law revisions, primarily financial safeguards including investment guardrails and ability to establish steadfast earmarks. Attendees marked paper ballots.

Lund provided a summary of the Covenant Amendment campaign's impetus, process and initial results for seven WOHA-proposed revisions. All 1,100+ ballots distributed and more than 600 ballots cast to date. All amendments are popular with respondents, but likelihood of majority approval among eligible property owners varies by Unit. However 74% of residences fall within just 7 of the 29 Units which are on track for ratification of most amendments. Open floor debate followed with several attendees voicing support for various amendments while others raised concerns about enforceability as well as fairness and civility within the process. One speaker was interrupted and Lund reiterated meeting rules for respectful engagement. Lund called for a straw poll that confirmed well over 90% of attendees wanted the Board to push forward and secure as many amendment approvals as possible in the coming months.

Lund called board elections for 6 expired seats. 10 candidates appeared on the ballot and winners (Romo, Wiese, Witt, Sewell, Lopez, Beneke) were tallied immediately following meeting.

Lund adjourned the meeting.
